CONNECTIONS MATTER

As we welcome spring I'm reminded May, one of my favorite months, is Older American's Month (OAM). Established in 1963, OAM provides an opportunity to recognize older adults' contributions, highlight aging trends, and reaffirm commitments to serving the older adults in our communities. This year's theme, "Powered by Connection," focuses on the profound impact that meaningful connections have on the health and wellbeing of older adults.

As we get older, changes in our personal circumstances and lifestyle may result in us feeling less connected to others and increase the risk of becoming lonely. However, loneliness is not an inevitable part of getting older - there are lots of things that can be done to expand and strengthen an individual's connectedness.

Now in our 58th year, Seniors First has been helping our clients build

and maintain these social connections through a wide variety of programs designed to promote engagement and encourage participation. Our Meals on Wheels program relies heavily on an army of over 350 volunteers to deliver 900-1,100 meals daily. The safety checks and socialization they provide contribute to an individual's overall sense of well-being, especially those living alone. Companionship services offer clients personal one on one assistance in their own homes and telephone reassurance calls keep clients connected. Through access to socialization, exercise, games and nutritional education, the Neighborhood Lunch Program (NLP) at select sites throughout Orange County enhances quality of life through active participation. And finally, Project Connect, an innovative technology program that provides senior-friendly Samsung tablets (Claris Companion) to connect clients to family, friends, each other, and the community has proven to be another very effective way for us to increase socialization.

Connections matter and we are truly grateful for your support of our work to combat loneliness, isolation, and hunger. Through the delivery of nutritious meals, companionship, telephone reassurance, NLP and Project Connect, we will continue to enrich the lives of our seniors.

GET READY TO VOTE!

As we all know, 2024 is an election year. But what you may not be aware of is that all "vote by mail" applications expired on 12/31/2022. If you have not completed a new VBM application since that time, call or go to the Supervisor of Elections office for your county. All VBM requests must be submitted at least 12 days prior to an election.
